

# A Guide to Government Funded Hours for 2, 3 and 4 year old Children

# 2 Year Old Funded Hours for Eligible Children 570 Hours per year

Some 2 year olds in England may be eligible Funded Hours. (see Eligibility Checklist Booklet)

Northumbria Nursery delivers this funding as a 'Stretched Entitlement' over 50 weeks.

Eligible children can claim 3.8 hours of 2 Year Old Funded Hours per session (morning/afternoon) up to a maximum of 2 sessions per day, to a maximum of 3 sessions per week for 50 weeks per year.

2 Year Old Funded Hours session Morning = **7.45am to 1.00pm: 5.25 hours** 

2 Year Old Funded Hours session Afternoon = **1.00pm to 6.15pm: 5.25 hours** 

2 year Old Funded Hours session Full Day = **7.45pm to 6.15pm: 10.5 hours** 

#### How Do I Claim 2 Year Old Funded Hours?

2-Year-old Funded Hours are claimed by the nursery on your behalf after you have returned your completed forms (see How to Apply)

For each term claim, a child must be in attendance at the nursery on or before the Headcount Date which is advised by the Local Authority and are a specific date usually towards the beginning of each term. If a child starts nursery after the Headcount Date, the Nursery will submit a late claim to the Local Education Authority but cannot deliver 2 Year Old Funded Hours until approved.

### How are the 2-Year-Old Funded Hours Delivered?

Northumbria University Nursery delivers an **inclusive** service, which includes your full session hours and an exceptional provision of additional services for care and early years' education that substantially exceeds the requirements for the funded hours set out by the Department for Education. (see Additional Services at the end of this document)

A new invoice will be calculated for you and your monthly fee will be reduced from the 25<sup>th</sup> of each month from when your funding begins. e.g. Funding begins in January then your new reduced monthly fee will be payable on 25<sup>th</sup> January.

If you currently pay for fees via childcare vouchers or Tax Free Childcare, you may need to amend the amounts you pay to nursery as your invoice will be less than you used to pay. An 'Amendment of Payment Method' will be included with your new invoice for you to complete and return to reception.

# Universal Funded Hours for All 3 and 4 year old children

# 570 hours per year

**All** 3 and 4-year-olds in England are entitled to maximum of 570 hours of free early education or childcare hours per year.

Northumbria Nursery delivers this funding as a 'Stretched Entitlement' over 50 weeks.

Children can claim 3.8 hours of Universal Funded Hours per session (morning/afternoon) up to a maximum of 2 sessions per day, to a maximum of 3 sessions per week for 50 weeks per year.

Universal Funded Hours Morning session: **7.45am to 1.00pm: 5.25** hours

Universal Funded Hours Afternoon session: **1.00pm to 6.15pm: 5.25** hours

Universal Funded Hours Full Day session: **7.45pm to 6.15pm: 10.5** hours

## How Do I Claim the Universal Funded Hours?

Universal Funded Hours are claimed by the nursery on your behalf after you have returned your completed forms (see How to Apply)

For each term claim, a child must be in attendance at the nursery on or before the Headcount Date which is advised by the Local Authority and are a specific date usually towards the beginning of each term.

If a child starts nursery after the Headcount Date, the Nursery will submit a late claim to the Local Education Authority but cannot deliver Universal Funded Hours until approved.

Northumbria University Nursery delivers an **inclusive** service, which includes your full session hours and an exceptional provision of additional services for care and early years' education that substantially exceeds the requirements for the funded hours set out by the Department for Education. A new invoice will be calculated for you and your monthly fee will be reduced from the 25<sup>th</sup> of each month from when your funding begins. E.G. Funding begins in January then your new reduced monthly fee will be payable on 25<sup>th</sup> January.

# Additional Funded Hours for Eligible 3 and 4 year old children 1140 hours per year (also known as 30 hours)

Some 3 and 4 year olds in England may be eligible Additional Funded Hours. (see Eligibility Checklist)

Northumbria Nursery delivers this funding as a 'Stretched Entitlement' over 50 weeks.

Eligible children can claim 3.8 hours of Extended Funded Hours per session (morning/afternoon) up to a maximum of 2 sessions per day, to a maximum to a maximum of 6 sessions per week for 50 weeks per year.

# **Fully Funded Hours Place Only**

# 570 Hours per year/1140 Year

Northumbria University Nursery offers up to one Fully Funded Hours Place per session, (subject to eligibility) per day that is not conditional on any charge or charges and is offered subject to availability in accordance with the requirements for the funded hours set out by the Department for Education and as determined by our business model to remain sustainable.

Eligible children attending can claim 2.28 hours of funded hours per session (morning/afternoon) of their contracted attendance up to a maximum of 2 sessions per day to a maximum of 5 sessions per week for 50 weeks per year if claiming 570 hours per year.

Or up to a maximum of 2 sessions per day to a maximum of 10 sessions per week for 50 weeks per year if claiming 1140 hours per year.

A Fully Funded Hours Place is;

Fully Funded Morning session: 9.00 am to 11.20 am: 2.28 hours

Fully Funded Afternoon session: 1.00pm to 3.20pm: 2.28 hours

# How Do I Claim a Fully Funded Hours Place Only?

If you selected a Fully Funded Hours Place on your original application form, the Nursery Manager (Judith Curry) will contact you to discuss availability and allocation.

If your child is already attending Nursery and you wish to transfer onto a Fully Funded Hours Place, please indicate this on your Funded Hours Agreement and the Nursery Manager (Judith Curry) will contact you to discuss availability and allocation.

Fully Funded Hours Places are claimed by the nursery on your behalf after you have returned your completed forms (see How to Apply)

For each term claim, a child must be in attendance at the nursery on or before the Headcount Date which is advised by the Local Authority and are a specific date usually towards the beginning of each term.

If a child starts nursery after the Headcount Date, the Nursery will submit a late claim to the Local Education Authority but cannot deliver Fully Funded Hours until approved.

## How is a Fully Funded Hours Place Only Delivered?

For parents choosing a Fully Funded Hours Only Place, the facility to purchase additional hours is unavailable. Requests for changes to sessions or the days allocated by nursery are not possible and allocated sessions are fixed until the end of the term. For parents taking up this option, funded sessions cannot be used before 9am, after 3.20pm pm and during lunch and tea times. (see Additional Services at the end of this document)

You will receive a Fully Funded Hours Place Only statement in January, May, and September confirming; how your fees have been calculated, and how many hours you are being funded.

Parents seeking a Universal Funded Hours (570 hours) or Additional Funded Hours (1140 hours) delivered outside of the session times and without the additional services offered at Northumbria University Nursery are advised to visit Newcastle Families Information Service who can provide advice and information of settings in Newcastle who may offer alternative Funded Hours options.
